3. Invoicing

Costs invoiced to the employer will be charged to the premium account.

Costs related to home ownership promotion (clause 2.1) will be charged to the insured person, the costs for individually agreed services (clause 2.6) will be charged to the respective client.

If the pension fund is dissolved or liquidated (clause 2.3), the costs will be deducted from the fund's unallocated assets before they are distributed.

4. Entry into force

This Schedule of Costs enters into force on 1 January 2023. It replaces all previous Schedules of Costs.
